Since 2007, we have been using payroll software from New World Systems Corporation. We would like to renew our software maintenance agreement with New World for the term beginning November 1, 2011 and ending October 31, 2014. The total contract price for the three year term is \$92,711, to be paid in annual installments. The 2011 and 2012 appropriations were included in our budget requests and adopted by the Board. However, no payments for 2011 and 2012 have been made.

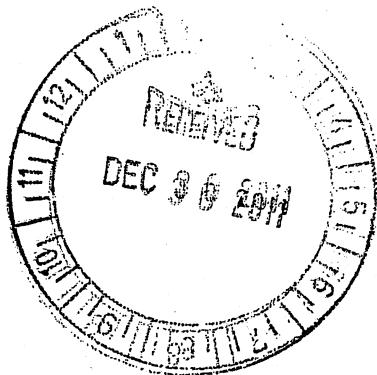
The contract is being submitted after its effective date as we have been in negotiations with New World on the price, resulting in a savings to the County of \$8,372 over the term of the contract.
